NOW THIS INDENTURE WITNESSETHAS FOLLOWS:

- 1. In order to effectuate the said desire of the Settlers, they do hereby hand over to the Trustees a sum of Rs. 3000/- (Rupees Three Thousand only) the receipt of which the Trustee hereby acknowledge to hold and stand possessed for the same (hereinafter for brevity's sake referred to the 'Trust Fund' which expression shall also include each and any other property and investment of any kind whatsoever into which the same of any part thereof might be converted involved or varied from time to time or such as may be acquired by the Trustees or come to their hands by virtue of these presents or by operations of law or otherwise howsoever in relation to these presents upon the trust and with and subject to the powers, provisions, agreements and declarations hereinafter declared and contained of and concerning.
- 2) NAME
- a) The name of the Trust shall be 'VIDYODHAYA EDUCATIONAL AND CHARITABLE TRUST'.
- b) The Registered Office of the Trust shall be situated at Peringara, Pottayil Lane off M.G. Road, P.O.Poothole, Pin code-680 004.
- c) The area of operation of the Trust shall be the STATE OF KERALA, but shall be extended to other areas if and when it is so necessitated and if the man power and financial situation so permit.

3. OBJECTS

- a) The objects for which the Trust is established are education, vocation training, dissemination of knowledge and ideas for economic and social changes and betterment of life and living of public at large, publication, relief of the poor, medical relief, welfare and advancement of any other charitable objects of general public utility not involving the carrying on of any activity for profit and for such purposes for the benefit of the general public without discrimination of caste, creed, colour, religion or sex of the beneficiaries.
- b) To promote education, spiritualism, culture and charity by establishing and managing educational institutions like Schools, Colleges, Universities and other educational institutions,

scientific and technical and do all things that are necessary for establishment, management and promotion of such institutions. The Trust may also take up the management of such institutions established by any similar Trust or Association registered under the Indian Trusts Act, Societies Registration Act or any other enactments in force or that may be brought into force by the State or Central Government.

- The Trust may establish, conduct, maintain and or manage reading rooms, libraries, institutions for promotion of fine arts, games, sports and tournaments, centres for spiritual studies, donate charities, establish endowments, tape libraries, both audio and video, gymnasiums workshop, publishing houses, printing presses, hostels, residential quarters, conduct seminars, discourses, and the like.
- d) To establish, acquire, run, maintain, support and/or grant aid in cash and./or service and publishing houses to print, edit, publish and circulate in Indian Union, newspapers daily or otherwise news magazines, weeklies, periodicals, leaflets, pamlets, books and such other materials.
- To establish and maintain studentships, scholarships, fellowships and render other kind of aid to individuals including supply of medicine, books stipends and assistance medals, awards and other incentives to study and research.
- To grant aid, to promote establish, support and/or maintain institution for the promotion of social sciences, economics, politics and development studies, literature, fine arts including FOLK-lore Arts and for the research and other institutions having similar objects.
- To provide help to the needy, the destitute, the physically handicapped and the poor without any distinction of caste, colour or creed.
- To grant relief during natural calamities such as famine, earthquake, flood, fire, pestilence and other occasion or calamities of similar nature and to five donations, subscriptions to Institutions, establishments or persons during such relief work.
- To render assistance and/or grant in aid to other public charitable trusts or institutions.
- To acquire movable and immovable property for the office of the Trust and other facilities

- k) To do everything incidental to conducive for the achievement of the above objectives.
- 1) To do any other act for the advancement of general public utility not involving the carrying on of any activity for profit.
- m) To utilize the income of the Trust towards the promotion and furtherance of the aim and objects mentioned or decided subsequently.

4. ACCOUNTS

The trustee shall cause true and correct accounts of all moneys received and spent and of all matters in respect thereof in the course of management of the Trust properties or in relation to the carrying out of the objects and purpose of the Trust as well as of all assets, liabilities, credits, and effects of the Trust properties.

5. POWERS

For the futherance of the objects of the Trust and for the investment or use of Trust funds for the time being in force, the Trustees will have the following powers:

- To accept any donation, contribution, grant or subscription in cash or in kind from any person, body or persons or trust with or without conditions.
- b) To apply the whole or part of the income of the Trust fund or accumulation thereof or whole or part of the Trust fund to anyone or more if the objects of the Trust as the Trustees may in their discretion from time to time determine.
- c) To convert and deal with the Trust property and/or to carry in investments for the time being.
- d) To invest and keep invested of the Trust Fund either in immovable property or in shares, stock or debentures or other securities and investments and to alter, vary or transpose such investments from time to time as the Trustees may in their discretion think fit for others of the same or of like or different as prescribed in the Income Tax Act, 1961 or such modifications as may be brought therein.
- e) To borrow or raise or secure payments of moneys.
- f) To sell, dispose of, alienate or otherwise deal with any property for the realization of the Trust objects which shall be in the best interest of the Trust.

- To acquire and dispose of immovable properties of every description and nature.
- To let out, demise any immovable property for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- To open in the name of the Trust and/or institutions run/conducted by the Trust with a bank or banks and to operate such account and to give instructions to the bank and to provide the opening and operation of such account by any one of the trustees who are so authorized by the Trust.
- To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands, and proceedings, regarding the Trust Fund.
- To appoint constituted attorneys or agents and to delegate to such attorneys or agents any powers and from time to time remove such attorneys or agents and to appoint other or others in his or their place.
- To appoint or make provision for the appointment or any person for the purpose of the administration of the Trust property or Trust institutions in such manner and subject to such rules and regulations as the Trustees may prescribe from time to time which the Trustees shall think fit for the realization of the objects of the Trust.
- To make, vary, alter, or modify schemes, rules and regulations, for carrying out the objects of the Trust and for the management for the affairs thereof and./or running any institutions in therance of the objects of the Trust and otherwise for giving effect to the objects of the
- To start, abolish, discontinue and restart any charity or charitable institution for the benefit of the general public and to impose any conditions to any subscriptions or donations made by
- To set apart and/or allocate the whole or part of the income or the corpus of the trust fund or part thereof for any of the objects of the Trust.
- To join, co-operate for amalgamate this Trust with other or others having similar or allied objects, upon such terms and conditions as the Trustees may in their discretion think fit, particularly having regard to and in conformity with the objects in nature of this Trust.

7 LIABILITY.

The Trustees shall be chargeable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, defaults, acts or omission or commission of any banker or other person with whom the Trust properties or any securities may have been deposited or kept.

8. Indemnity.

The Trustees are entitled to be reimbursed themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

9. NUMBER OF TRUSTEES

The number of Trustees shall be seven with a provision to make it upto ten.

10. APPOINTMENT OF TRUSTEES ETC.

Sajeevkumar P.H. shall be the Managing Trustee and Smt. Sruthi K.V. shall be the Secretary. The other trustees shall be appointed by the board of Trustees from time to time. The Board of Trustees shall have power also to remove any Trustee for any reason of his acts which the Board shall think detrimental to the interest of the Trust.

RULES OF BUSINESS

The Trustees may from time to time frame rules for the conduct of the administration of the Trust.

12. APPOINTMENT OF EMPLOYEES:

The Trustees shall have to power and discretion instead of acting personally, to employ and pay only agent (including any bank) to transact any business or to do any act whatsoever in

relation to the Trusts of these presents including the receipt and payment of moneys without being liable for loss and shall be entitled to be allowed and paid all charges and expense incurred thereby.

13. POWERS OF MANAGEMENT AND FUND ADMINISTRATION

- a) The day to day management of the Trust shall vest with the Managing Trustee. The Managing Trustee shall have the power to determine in case of doubts whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income of capital any expenses or outgoings ought to be paid or borne and on every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorise the Managing Trustee to spend the income or corpus of the Trust for any purpose not authorised by these presents.
- b). It shall be lawful for the Managing Trustee to settle all accounts and to compromise, compound abandon or refer to arbitration any action or proceedings or disputes, claim, demand, or things, proper for such purpose without being responsible for any loss occasioned thereby.
- property comprised in the Trust Fund or otherwise for all of any of the purpose of these presents and it shall be lawful for the Managing Trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as that may in his absolute discretion think fit, subject to ratification by the Board of Trustees.

14. It shall be lawful for the Board of Trustees:

a) To apply to the Government, Public bodies, Urban, Local, Municipal, District and other bodies, corporation companies of persons for and to accept grant of money and of aid, donations, gifts, subscriptions, and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Government, Companies, or persons, scheme and other and matter within the objects of the Trust and to confirm to any proper condition upon which such grants and other payments may be made.

- To make over or amalgamate with any other charitable trust, society, association or Institution similar objects.
- To establish, promote, manage, organise or maintain or to assist in establishing, promoting, managing organising or maintaining any branch of the Trust or any other Trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.
- d) To make over, acquire, manage, control or aid any existing institutions or institutions having objects either wholly or in part in agreement to the objects of this Trust and on such terms and conditions as may be brought expedient.
- e) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with this Trust is authorised to amalgamate.

15. AMENDMENT OR ALTERATION

No alteration or amendment or addition or modification shall be made in the foregoing unless the alteration, addition amendment of modification is:

- a) First accepted by the majority of the Trustees.
- b) Approved by the Commissioner of Income Tax under whose jurisdiction of Trust falls.

16. ACCOUNTING YEAR

The accounting year of the Trust shall be the Financial year.

17. AUDIT

- a). The Accounts of the Trust shall be audited every year by Chartered Accountants duly appointed by the Trustees.
- b). The Trust is secular in spirit and public in nature.
- c). The Trust funds shall be and remain irrevocable for all times. But, in case the Board feels that in the best interest of the public it is better to wind up the Trust and the objects of the trust can better be achieved by some other manner, it may decide to wind up the Trust. If the decision is taken to wind up the Trust, the remains of the assets, after satisfying the liabilities,

shall be transferred to a Trust/Charitable institution with similar aims and objectives of the Trust duly registered under the then prevailing laws or, in the absence of such a Trust/charitable institution, to the Government.

19 DECLARATION

It is expressly declared that no part of the Trust property or income of the Trust fund shall be applied for any purpose outside India or for any purpose which is not a public charitable purpose in law and all provisions here of shall be construed accordingly.
